Gentleshaw Birds of Prey and Wildlife Centre, New Hospital Unit Grand Opening, Sunday 26th June 2011



Following a donation of £5,000 to Raptor Rescue from Pets at Home under their adoption/re-homing scheme, the Board of Trustees were left with a bit of a dilemma f how to spend the money. It was decided to split the money between Gentleshaw for the purchase of a new hospital unit and the rest to build some holding aviaries to be used by the Re-homing Coordinator.

The new hospital unit (left) is a refurbished portacabin from Midland Portable Buildings, who have laid it out to Jenny's specification.

The cabin was delivered in March and placed at the rear of Gentleshaw Wildlife Centre, Lesley and Jenny have since been fundraising

to kit it out. Their old unit had to be closed after the floor collapsed and the Trustees felt that replacing it was a good use of the money, especially as Gentleshaw are integral to the re-homing process.

The grand opening will take place on Sunday 26th June at Gentleshaw Birds of Prey and Wildlife Centre, Fletcher's Country Garden Centre, Stone Road, Eccleshall, Staffordshire, ST21 6JY at approximately 12.00 noon. It is hoped to have someone of notoriety to perform the opening ceremony. Trustees will be there along with a representative from Pets at Home. If any member would like to attend, they will get free access to the centre on production of their membership card.



Change in Procedure for Wild Disabled Birds

DEFRA has had concerns for some time over the number of wild Schedule 4 birds that are being registered for rehabilitation and then subsequently end up permanently kept in captivity. Consequently, they will be taking a stricter view to ensure that wherever possible, any wild Schedule 4 bird taken into captivity is rehabilitated and released back to the wild as soon as possible. To this end they will be inspecting keepers of wild Schedule 4 birds to check that rehabilitation is occurring and that the keeper has sufficient knowledge to successfully release the bird back to the wild.

DEFRA will also require keepers to take these birds to an avian vet and have it assessed (regardless of whether the bird is injured or not), as to the estimated time it will take to rehabilitate and release; or alternatively give an expert explanation as to why the bird cannot be released. Forms are available on the DEFRA forms page for vets to download and fill in the details.

With regards to applications for Article 10's for wild disabled birds; whether they are on Schedule 4 or not DEFRA will be taking a stricter view of Article 8.3 of EC Regulation 338/97 when considering applications to use any wild birds commercially for breeding and or educational display purposes for the conservation of the species. DEFRA will only be granting them where there are genuine exceptional conservation benefits to the species.

Raptor Rescue Events

Further to the list of events published in the last newsletter, Raptor Rescue are not able to attend the Falconry Fair on 1st & 2nd May, as the Trustees who normally attend are not able to do so this year, coupled with a shortage of helpers. Likewise, we may not be attending the Chatsworth Show in September for the same reasons.

Hawk Board Guidelines

The Hawk Board have issued (April 2011) a set of guidelines for keeping birds of prey in captivity, which includes rehabilitation. It is understood that they started these in response to the Animal Welfare Act 2006 and the possible need for code of practice, such as those that exist for cats, dogs, horses and primates available on the Defra website. Our Trustees have yet to discuss the contents with the Hawk Board
